Here are just a few of the many wins for Oregon Realtors® in 2019.

Top 10 Highlights:

1. **REALTOR® Day at the Capitol**- Over 800 Realtors® showed up to support our industry and demonstrate the power of Oregon Realtors®.
2. **NAR's Broker's Edge** – NAR selected our state to co-host this event to bring national industry experts to Oregon.
3. **Oregon Leadership Academy**- This program relaunched in 2019. A successful group project, the RPAC Video Challenge, created awareness and new investors for RPAC.
4. **RPAC Investors**- 2019 saw a record number of Major Investors, new investors and overall participation.
5. **Commitment to Excellence (C2EX) Contest** –OAR, as a whole, achieved high marks for member completion of the program and placed third in the nation-wide contest. Berkshire Hathaway HomeServices Salem Branch took first place for top brokerage competition.
6. **Awarded \$186,500 in HOME Foundation grants** – Several successful fundraisers were held throughout the year, including the Driving it HOME golf tournament and the Taste of Oregon.
7. **Strategic Priorities** – Revamped our association priorities for the next three years to be Better, Stronger, Lead, Support and Connect.
8. **Local Associations & Brokerage Visits** – Visited most of the local associations across the state and several brokerages.
9. **Committee Volunteers** – Received record number of applications from members wanting to get involved.
10. **Principal Broker Academy** – Launched first-ever high-level learning program for Principal Brokers.

I am excited about what we plan to accomplish in 2020. With an excellent team in place, I know we will continue to be the member resource for all things real estate.

Q&A WITH OAR PRESIDENT LORI PALERMO

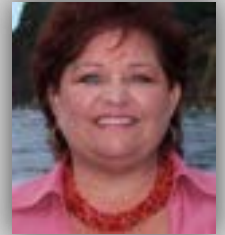

LEGISLATIVE HIGHLIGHTS

The 2019 Oregon legislature was led by Democrats in the House and the Senate. Legislative leaders came in with ambitious plans and accomplished many of them. The results included some big losses for the real estate industry, but also some major victories.

OAR AT THE LEGISLATURE

- More than 800 REALTORS® attended REALTOR® Day at the Capitol on April 2, 2019.
- REALTOR® [Jack Zika](#) (R-Redmond) completed his first session in the Oregon House of Representatives.
- After session, OAR member [Vikki Breese-Iverson](#) (R-Powell Butte) was appointed to the Oregon House of Representatives to replace former House Republican Leader Mike McLane, who left the legislature to become a Circuit Court judge.
- Rep. Zika, Rep. Breese-Iverson, and [Rep. Mark Meek](#) (D-Gladstone) make three OAR members serving as Oregon legislators.
- With over 3000 bills introduced, the Government Affairs Key Committee (GAKC), under the leadership of OAR member Randy Shaw, identified over 400 bills impacting the real estate industry.

2019 ISSUES MOBILIZATION

OAR's Issues Mobilization Fund provides resources for state and local ballot measures and issue campaigns. Associations apply for funds which are granted by a committee of OAR members. Here are a few examples:

Central Oregon – Affordable Bend (proposed mandatory home energy score program)

A mandatory Home Energy Score program would require that homes have a home energy report card at the time of listing or at the time of sale. It would add cost, complexity and time to transactions, and a mandated program eliminates a homeowner's ability to choose whether they are willing to accept the impact of these factors. With a \$5,000 grant, COAR was able to engage members of the local community to communicate with the Bend City Council in the run-up to the City Council vote.

Oregon Association of REALTORS® - People Not Politicians

The Issues Mobilization Committee granted a request for \$10,000 to support the initial phase of the "People Not Politicians" campaign, a ballot measure to create an independent commission for legislative and congressional redistricting. Currently, redistricting is conducted by the legislature and is subject to "gerrymandering" where politicians draw maps to serve their own interests rather than those of the voters. Nonpartisan redistricting is important to the real estate industry because partisan "gerrymandering" has led to increased political polarization in Oregon and Washington D.C., making it difficult for the parties to come together and solve important challenges facing Oregon communities.

Eugene Association of REALTORS® - Better Eugene Springfield Transit

The Lane County REALTOR® Associations have been critical partners in creating a 50+ member coalition, Better Housing Together, that has successfully pushed the Eugene City Council to pursue policies aimed at increasing the affordability, diversity and supply of housing. The Issues Mobilization Committee granted a \$1250 funding request to assist the coalition with advocacy on issues before the Eugene City Council.

LEGISLATIVE FORECAST

WHAT TO EXPECT IN 2020 - LEGISLATURE

The “short” 35-day legislative session begins February 3, 2020. OAR will provide regular updates as it becomes clear which bills are introduced and where they are heading. For now, here is what we are watching for:

1. OAR is working with other partners to pass legislation to allow accessory dwelling units (ADUs) in rural residential zoned land.
2. OAR is working with other partners to pass legislation increasing funding for the “Clean Water Revolving Loan Fund” which helps homeowners repair or replace failing septic systems.
3. Three OAR members (Rep. Jack Zika, Rep. Mark Meek, and REALTOR® Debra Neal) serve on the [Joint Task Force on Addressing Racial Disparities in Homeownership](#). The Task Force will be bringing forward legislation aimed at boosting minority homeownership and reducing instances of housing discrimination.
4. The [Governor’s Council on Wildfire Response](#) developed a report with recommendations for legislation and rulemaking to reduce the risk of catastrophic wildfires. Several of the recommendations deal with land use, building codes and creating “defensible space” around homes and other structures to protect them from wildfire. We will be watching legislation closely as it develops.
5. We will be watching the revenue committees closely for any legislation that attempts to reduce incentives for homeownership (i.e. changes to the mortgage interest deduction) or real estate investment (i.e. removing favorable tax treatment for investments in Opportunity Zones).

Rulemaking

The legislature passed significant housing policy reforms in 2019 that are now in the rulemaking phase. The [Rulemaking Advisory Committee](#) for House Bill 2001 (requiring cities to allow for “middle housing” types on single family lots) and HB 2003 (requiring cities to develop Housing Production Strategies) is underway. OAR staff is monitoring the rulemaking and participating on key subcommittees. Go [here](#) to check for updates or to subscribe for email updates.

Monitoring Effects of Rental Regulations

OAR and other housing-industry partners will be monitoring the impacts of recently passed legislation capping rent increases and eliminating no-cause terminations after the first year of occupancy. We will be looking for both quantitative and qualitative information to assess the impact of this legislation and to improve our efforts to make adjustments to the law in future sessions. Advocacy Presidential Advisory Group (PAG)

After the 2019 Legislative Session, OAR took the opportunity to do a strategic review of its advocacy program in light of the changing politics of our state. A Presidential Advisory Group (PAG) met numerous times over the summer to review OAR’s advocacy strategies and recommend a direction moving forward. The Committee’s topline recommendations were:

- Create a unifying, identifiable theme to drive our legislative and grassroots efforts.
- Spearhead the conversations, coalitions and solutions to address Oregon’s housing crisis.
- Strategically align OAR’s advocacy-related committees through regular joint meetings.
- Build authentic relationships with legislators on both sides of the aisle utilizing “key contacts” modeled after the Federal Political Coordinator Program.
- Develop and implement a communications program that tailors messaging for our three target audiences (legislators, OAR members and the public) and that highlights the positive role that REALTORS® are playing in addressing Oregon’s housing challenges.

LEGAL ADVOCACY

Owens et al. v. City of Portland

OAR participated as Amicus Curiae in this case before the Oregon Court of Appeals. The appeal challenged the Multnomah County Circuit Court's ruling upholding the City of Portland's "relocation assistance" ordinance that requires residential landlords to pay steep fees to a tenant (1) if the landlord raises rent by 10 percent or more in a 12-month period, and the tenant elects to move; and (2) if landlord terminates a monthly tenancy for "no cause" or a landlord elects not to renew a lease on substantially the same terms, and the tenant elects to move. OAR argued that the ordinance is preempted by the state law prohibiting local governments from enacting any type of rent-control measures, and that the restrictions on a landlord's right to terminate a tenancy are preempted by Oregon's Residential Landlord-Tenant Act (ORS Chapter 90). Oral arguments were heard before the Oregon Court of Appeals on January 7th, 2019. The Court has not come down with its decision. The Portland ordinance and the legal challenges took place prior to the passage of SB 608. We believe that the passage of SB 608 only strengthens our arguments that the issues in question—rent control and termination of tenancies—are governed by state, rather than local, law.

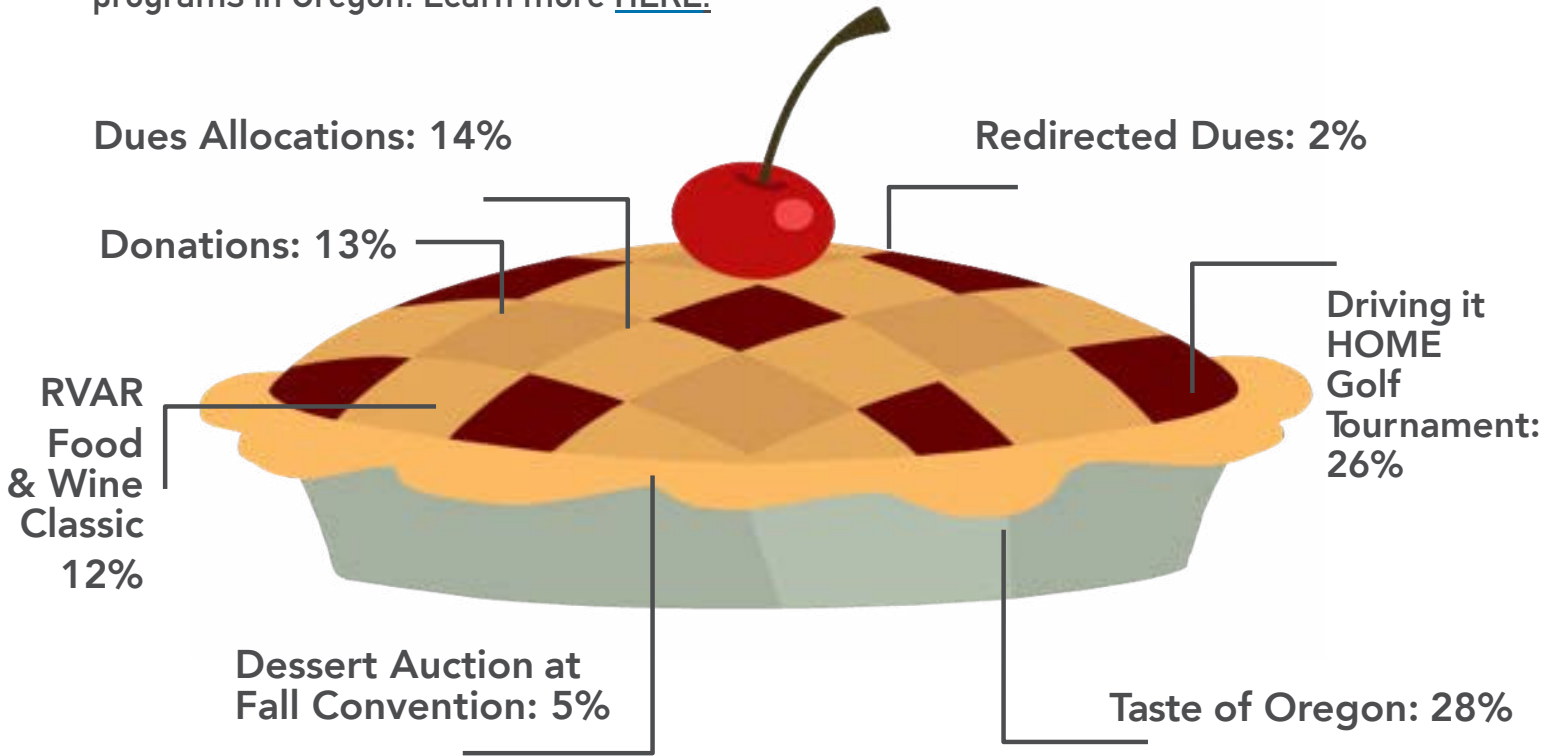
2019 Distinguished Service Award Co-Recipients Don Livingood and Lester Friedman
