

A yearly subscription allows for an unlimited number of questions for a cost of only \$125 annually. Available by phone Monday–Friday, 9:00 a.m. to 12:00 p.m. (except during NAR and OAR conventions and holidays) or e-mail questions any time. Responses within 24 hours.

Public Policy


The Government Affairs Team develops and recommends legislative policies concerning issues affecting the real estate industry, private property rights and your business.
