

GRI Graduation Application



To earn the GRI, you must take 60 hours of approved GRI content. The first 30 hours must be made up of Oregon GRI Core Courses – you can take any combination of courses offered anywhere in Oregon. The additional 30 hours of GRI content can be made up from additional Oregon GRI Core Courses or equivalency credit hours from approved designations and certificates.

Once you have completed your 60 hours of approved Oregon GRI content, you must register for GRI Graduation (\$60/member) (www.oregonrealtors.org/gri-graduation) and email this GRI Graduation Application to OAR for approval (education@oregonrealtors.org). OAR will validate your application with our records. You will receive email notification of your GRI status within 2 weeks and a GRI certificate and pin will be mailed to you. Once you have received confirmation of your GRI graduation, you are free to use your designation.

Your GRI Designation in 4 Steps:

- 1. Complete 60 hours of approved Oregon GRI content.
 - 1. 30 hours of Oregon GRI Core Courses
 - 2. 30 hours of additional Oregon GRI Core Courses or approved designations/certificates
- 2. Register for GRI Graduation www.oregonrealtors.org/gri-graduation.
- 3. Submit completed GRI Graduation Application (include applicable course completion certificate copies) education@oregonrealtors.org.
- 4. OAR will notify you with your graduation status within 2 weeks.
