### ORPAC-Supported Candidates Have:

- Established the Oregon Housing Needs Analysis as the new housing planning framework for the state; cut red tape for housing production; established and funded related programs (2023 bills – HB 2001, HB 2889; 2024 bills – SB 1537, SB 1530)
- Regulated residential property wholesaling; prohibited long-term predatory contracts; required use of written representation agreements for real estate services (2024 bill – HB 4058); modernized statutes governing the real estate profession to align with contemporary industry practices (2025 bill – HB 3137)
- Successfully defended against attempts to eliminate the Mortgage Interest Deduction (2021 bills – SB 852, HB 2578, HB 2838)
- Reduced termination notices in certain circumstances and enabled buyers to purchase a tenant-occupied unit in plexes with a primary-residence loan (2025 – SB 586)
- Reformed Construction Defect Liability for Condominiums to Spur Production (2025 – HB 3746)
